The list may not be transferred, sold, duplicated, posted or published in any medium, in whole or in part. The list may not be used for commercial or any other purposes not authorized by the CDP. Unauthorized use of the list beyond permissible purposes is strictly prohibited. Failure to adhere to the terms will result in revocation of the requester’s right to use said list, loss of the requester’s right to request DSCC Member Lists for the remainder of the DSCC term, and, if applicable, prosecution or other legal action.

The CDP DSCC Member List is as of the deadline prescribed by the CDP Bylaws and Rules. No changes may be made to the list past that deadline except as permitted by the CDP Bylaws, or as necessary to mitigate possible issues (e.g., voter registration discrepancy or changes, voter contact information update) or clerical error.
